Task 1

Preparation of Environment and Social Impact Assessment (ESIA) addressing the aspects not covered under Task 1. An Environment and Social Management and Monitoring Plan (ESMMP) to be included in the ESIA.

- a. Final cost estimate.
- b.DIB document
- c.BOQ and technical specifications
- d.Work methodology
- e.Schedule of implementation
